- 1) Ignition warning light stays on >>> Remove alternator and send to shop for a rebuild. Replace.
- 2) Noise in rear end>> Replace LH wheel bearings and seals
- 3) Replace engine cooling fan otter switch, leave override switch connected
- 4) Remove heater control valve and reseal
- 5) Adjust throttle linkage to remove excess play
- 6) Clutch or Transmission problem.>> Checked clutch slave cylinder, it has been recently replaced and was in very good condition. Checked clutch master cylinder, it was leaking inside the car, so I replaced it. Drained transmission gear oil, found it to be about 1qt. low, refilled with Mobil 1. Noticed that after the transmission gets warm, it it still difficult to get into gear, particularly third gear. Suspect that the culprit is the synchronizers in the transmission, which requires a complete tear-down to repair.

- 1) Remove engine and transmission
- 2) Disassemble transmission, clean, replace seals, syncro-rings, roller bearings, and gaskets. Reassemble.
- 3) Remove and Replace clutch assembly. Turn flywheel. Replace pilot shaft bushing
- 4) Remove engine oil pan, take to machine shop for repair of stripped threads at drain plug. Replace front oil seal and by-pass hose, Reinstall pan.

- 1) Weber carbs stutter at 2500 rpm >> Troubleshoot and test drive. Found vacuum tank one-way valve to be leaking causing a vacuum leak on rear carb, replaced same. Synchronized linkages. Tried various jet combinations and finally settled on a 60F8 idle jet and the 165 main jet combination. Works great except at idle where it tends to pop back at times.
- 2) Attached choke cable to all three carbs
- 3) Installed air cleaners.

- 1) Throttle linkage levers tend to move on the shaft. I have tightened them as much as I dare. Hope they will stay in place.
- 2) Idle screw in the #4 carb is bent. Seems to work ok, but could be an issue.
- 3) Noticed that the butterflies on each carb are not perfectly in sync with each other. Thus there is no way to get all 6 of the butterflies to be in perfect sync. Don't know if this is an issue or not. Could be normal tolerance.
- 4) Engine runs better when cold, no spitting at all, suggesting that the mixture is still too rich. Maybe going to a 55F8 or 55F9 idle jet.
