Hi

I hope that you and your family enjoyed a special Thanksgiving together.

Here are a few items that IMO are worthy of consideration; not based on usage but rather based on time.

- 1. Tires are the only exception as they fall into usage and time; all 4 need to be replaced.
- 2. The Halon fire suppression system needs to be topped off; sadly I am unable to ship the bottle to SafeCraft because it is classified as Hazmat however, I can make the arrangements for you to take it there as they are close to you and arrange a customer waiting refill once I have her back with you.
- 3. The oil pump drive belt falls into the 6 years or 60K miles so it is something that should be considered particularly as your stable has grown and the regular usage will likely remain limited.
- 4. Oil and filter service and a pair of air filter.
- 5. Transaxle oil service; it was previously replaced however, since you did a fair amount of track activity before relegating her to the street it may be a good idea to have a fresh load of oil in it.
- 6. Brake and clutch fluids; since I do not know how much time has been cycling her aggressively since these fluids were serviced I did a moisture test; at this time they are both fine but you may want to have fresh fluids as the usage; both amount of and type has changed over the past few years.
- 7. Coolant system flush; this is one of the areas that could go either way as it was previously done; I think this is simply a question as to whether you want her truly fresh
- 8. A/C service is something that unless a gross leak or failure occurs is often over looked and yet even the best of systems have an incremental loss as such charging the system every 10 years or so insures that you do not find yourself unexpectedly blowing warm air.
- 9. Spark plugs; not because of an issue but rather because it has been awhile.

I have inspected all of the hoses and I see none that require attention at this time. I also did a load test on the battery and it remains fine at this time.

Lastly; when your time permits can you send me a check for \$5300 to be applied to that which I have already done.
