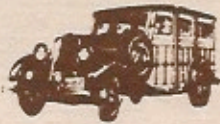

We are in receipt of your letter and hope your Easter week-end was pleasant.

We are going to have the repairs and door skins finished, as we mentioned in our last letter by the May 3rd. date.

As for the finish-sanding, oxalic acid treatments, color-matching and sealer coat, it is not feasible to hope to finish all of this by the May 3rd. date.

Also, it appears that we are not eliminating very much at all, of the "Refinishing" aspect of the car, since we have already stripped the old finish off, and you have requested that we finish-sand, oxalic acid treat, color-match and spray a sealer coat! This is approximately 75-80% of the "Refinish" aspect.

All that remains to be done, would be to apply a few coats of varnish. So, it appears to me, that you will be saving yourself approx. 25% of the cost of re-finishing (you will be paying us 1500. instead of the original 2000. quoted).

We will continue working on the trunk and panels until we hear from you at your earliest convenience concerning these above mentioned items.

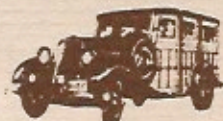
As you will recall the primary reason for our proceeding with you was your assurance that the old wood would refinish to perfectly match any new wood.



We received your note today and want to thank you very much for paying the towing charges.

We want to let you know that in reference to "structural integrity", it is paramount to us, and we want to assure you that we will be getting the very best possible fit in the mentioned areas.

It appears by your next comment, that you are under some misconception that the color-matching is somehow part of the structural repairs and re-fabrication of wood parts (WOODWORKING ASPECT), (which I might add, is as far as we will be going on this project) when in reality, it is part of the (RE-FINISHING ASPECT) of the job.

To clarify:

The RE-FINISHING ASPECT includes:

1. stripping down of old finish (which we have done and would like to be re-imbursed for)
2. finish sanding
3. oxalic baths
4. color-matching new parts to match old
5. numerous coats of varnish (sand-blocking between coats)
6. rub-out
7. final re-assembly

Consequently, since this latest development, we will not be doing anything related to the finish aspect (beyond the stripping), and will be completing the woodworking only.

We are extremely booked at the moment but have this project on our "Top Priority" list and just as soon as the woodworking is complete we will contact you immediately to move the car back to San Francisco.

Dear Mr. Carr:

Your telephone request yesterday to break our contract was received with some concern. While trying to understand your current delays, having reluctantly tolerated them in the past, I am concerned over several items.

First, the overall structural integrity including, but not limited to:

- (1) Overall fit of doors and rear deck lid with related hardware to the car.
- (2) Rear roof and fender fit to wood quarters.

Next, the blending of the new and old wood assuring a perfectly matching finish is a major concern.

Finally, the details of the wood work including, but not limited to:

- (1) Hip rail contour from the front doors through the back doors and on through the quarters and across the rear deck lid and floor.
- (2) Sill rail contour across bottom of front to rear doors.

- (3) Quarter cross bow to steel roof and side quarters, down to deck lid rails.
- (4) Fit of all small parts: tail lite and stop lite pads, door post contour inserts, roof rack side rails and deck slats, side and ceiling tack strips.
- (5) All of the other fitting, reproductions and finish we have agreed to from time-to-time.

I'm confident you can resolve these concerns thus allowing me to move the car to San Francisco as soon as possible.

We will also need your instructions on the paint and subsequent reassembly procedure and will shoot it in our facility. I hope this resolves your request to remove the car from your shop prior to its completion.

I've enclosed a copy of a recent Timber-Tales article on tail lite pads which might be useful to you.

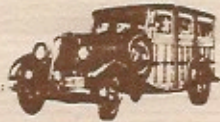

Hell-o there. As you can see, we have constructed most of the rear deck lid. In order for us to finish-up the last phase before the finish (varnish) is applied, we must have the rear tail lite housings, and the rear center stop lite housing.

Also, the veneer you supplied us, obviously is not useable for the trunk. The labor is part of the contract but the materials were to be supplied by you. We have a source where we obtain this veneer (paper-backed African), but we hope you will re-imburse us. We also used this same veneer on the doors, you will recall. The veneer runs 46.00 per roll. Including the front doors we will be using a total of 4 rolls. If we could receive the aforementioned parts and a check in the amount of 200. (184.veneer&16.shipping), at your earliest convenience, we will forge full-steam ahead.


Also in your letter, you mentioned in phase #2 that you wanted us to fit-up fenders, we will need them in order to do this for you.

Dear Doug:

Per our phone conversation today and your March 6, 1984 revised Job Estimate it is my understanding that you require increasing the structural work (doors, quarters, deck lid, etc.) from a \$3,000-4,000 cost to \$4,000.

This reduces the likelihood of available surplus for paint application thus allotting only \$1,000 for finish from our original \$5,000 budget.

Accordingly I will accept your revised \$4,000 repair proposal together with \$2,000 for finish (per your suggestion). This new \$6,000 budget shall include all discussed structural work, final finish, and doors, quarters and deck lid all permanently mounted with re-assembly detail up to us. All wood, however, shall be cut, routed, drilled or otherwise prepared to accept the applicable hardware.

For the purpose of establishing acceptable payment points we agree to the following milestones.

- 1) \$2,000 (already paid), in advance, for completion of doors and door inserts with post, sill, hinges and latches fit as required.
- 2) \$1,000 (to be paid), in advance, for completion of quarter panels and inserts, cross member, trunk floor, fenders and miscellaneous hardware fit as required.

- 3) \$1,000 (to be paid), in advance, for completion of all miscellaneous wood parts including, but not limited to, deck lid and insets, tail and stop light pads, roof rack, interior wood parts and miscellaneous hardware, including hinges, fit as required.

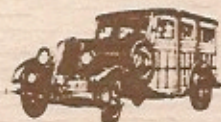

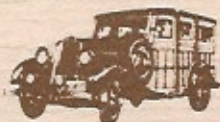

In reviewing the paperwork on your account, we are having difficulty in understanding why you have taken the liberty of "writing - in" your own figures. This does not constitute a contract to us, when the changes you made, were done after we signed and not before. Consequently, since your last correspondence with us, no work has been done on the car, because of this problem. We have a standardized format for working on cars. All of our customers follow this format. Changes made on contracts must be o.k.'d and signed or initialed by both parties. You have made changes without our consent.

Therefore, we are sending you another form to be signed and returned, voiding the first. Originally, as stated in our letter of 11-7-83, we quoted:

Structural repairs.....\$4000.
Finish.....\$2000.
Re-assembly.....\$2000.

Even though we mutually agreed upon this over the phone on Oct. 27, you later changed your mind and said you only had a budget of 5000. to utilize on restoring the wood on the car. We accomodated you by stating that we would write-up the contract at that amount and did. You then changed this,yourself,on the contract to a different amount,again without consulting us!!!, to an even lower amount. We cannot abide this type of game-playing and since we are voiding the contract, we are reverting,too. We are reverting to our original quote, either you accept it as it is, or there is one other option, explained as follows:
We are under the impression that you expressed a desire to re-assemble the car yourself, thereby, eliminating 2000. of the cost.

We are then left with a balance of 6000. You have paid 2000. so far and we have worked-off approx. 1500. of that amount. Please keep in mind that this document we are sending you is an "estimate" and our "standardized format" dictates that we allow for a 10% leeway on amount charged and no more. If a job runs over that amount, we absorb the cost.

If you have a strict budget of 5000., as you have stated, then we suggest you have the structural repairs done (which are the most important) and we can guarantee the amount will not exceed 4400. (4000. as quoted, and 10%+or- leeway) We don't feel that a 600. paint job would be up to our standards or yours, but that is a choice you will have to make.

If we are in agreement on the new contract, please sign and return "as is", OR you have the option of having us do 4400. worth of structural repairs and you can do the painting and re-assembly. How does that sound?

That way you can keep within your budget. You have already paid 2000. of it. We would like to resolve these points as soon as possible, as we have many cars waiting to come in and our space is limited and very expensive. We'll look forward to hearing from you at your earliest convenience.






