Following instructions received from Mr. D. B. Taylor, we have shipped the above motor car per m.v. "ATLANTIC SONG" which vessel sailed from Liverpool on the 19th instant en route for Portsmouth.

Attached herewith is one signed Bill of Lading (i.e. the document of title) together with the original Marine Insurance Certificate and Condition Report.

A further signed Bill of Lading and duplicate Marine Insurance Certificate are also being posted out to you by following airmail.

The steam cleaning certificate has been placed inside the car.

It will now be necessary for you to make your own arrangements with regard to Customs clearance etc., on arrival of the vessel at Portsmouth and we suggest you keep in touch with the Steamship Company's Agents, i.e. Ramsey Scarlet & Co. Inc., 109E Main Street, Norfolk, Virginia 23510, to ascertain the exact arrival date of the vessel, but which we would expect to be towards the end of January.

During loading operations the exhaust pipe was pulled adrift but the Steamship Company assured us that the damage is only very very small. In the event of your wishing to make a claim you would have to contact the Lloyds Agents at Norfolk before taking the car away and they are Henry Eagleton & Co. Inc., 430 Boush Street, Norfolk, but you will notice that there is an excess clause of £25.00 on the certificate.

We trust that you will eventually receive your Austin Healey in good order and condition.
