It isn't easy to find good quality Series III X Pack V8's with complete service histories. It is harder still to buy them at fair prices.

The car's history file in our possession is very comprehensive and can be summarized as follows:-

Delivered initially to Cooper Holdings Ltd of Swindon 1/3/88. We have a copy of the Factory Warranty Certificate.

Subsequently bought by RAB Productions Ltd of Walsall etc etc.

(5000 mile service, replace rear fog lamp switch, adjusting near side and off side upper ball joints, repairs to glove box, carry out valve clearance compression test - invoice number 9015 - £695.70)

(20000 mile service inc tightening all hoses and bolts, fit new drive belts, fit new set of spark plug leads, trace and rectify noise from heater motor in dash area, remove faulty vacuum solenoid to distributor and refitting with new wiring, remove drive shafts and loose spacer housing, clean and reassemble with Loctite, road test and final adjustments - invoice number 9178 - £1269.33)

(5000 mile service, balance wheels, fit new front brake pads, trace fault in near side main beam, investigating noisy wiper arm control in dash area, re-aligning near side door seal, road test and final adjustments - invoice number 9388 - £689.02)

(5000 mile service inc tightening all bolts and hoses, balancing wheels, cleaning down engine after fire damage in air box, fitting new seals, dismantle and re-assemble all carbs with new trumpets, resetting throttles and mixtures, remove, adjust and refit air conditioning valve, remove and refit tyre, road test and final adjustments - invoice number 9579 - £1100.78)

(10000 mile service inc tightening all hoses and bolts, replace faulty differential mountings, replace faulty exhaust clamps, fit new rear brake pads, fit reconditioned cruciform exhaust section, fit and adjust new drive belts, replace faulty lower brake reaction strut rubbers, fit new wiper arm bushes, fit new track rod ends and resetting front tracking, bleed and replace brake fluid, fit new clutch slave cylinder and bleed system, rectify faults in near side rear lights, attend to faults in drivers door wiring, re-align water temperature gauge, carry out air conditioning service, replace drier unit, recharge system, road test and final adjustments, - invoice 10218 - £2323.99)

(Repair both sets of horns by fitting new compressor, check over faulty air conditioning operation by fitting faulty control unit, replace air pump belt - invoice number 10302 - £393.58)

(5000 mile service, inc tightening all hoses and bolts, full engine tune inc dismantling and cleaning out carbs, reset float levels and balance throttles and mixtures, fit new starter motor, fit new water temperature sender unit, fit new exhaust mounting, check over suspension and steering and top up power steering fluid, adjust near side front wheel bearing and off side lower king pin ball joint, fit new clutch pedal return spring, new head lamp bulb, road test and final adjustments - invoice number 10337 - £1374.33)

## 29/01/93 (mileage not shown) by Chapman Spooner Ltd.

(12000 mile service inc tightening all hoses and bolts, rectify fault in spot light relay, fit new rear brake pads, fit new wiper blades, fit new fan belt, reset ignition timing, check carb needles, balance carb throttles and mixtures then road test, final adjustments. - invoice number 10425 - £906.64.)

#### 26/02/93 (mileage not shown) by Chapman Spooner Ltd.

(renew bottom hose, refill and pressure test the cooling system, drain and refill oil with Valvoline oil and fit new oil pressure sender unit - invoice number 10455 - £64.13)

At this point the car was sold (18/03/93 and 42975 miles - invoice number 30833) by Chapman Spooner Ltd via McCann Erickson to Mr J Clarke of Hampstead who also arranged Chapman Spooner to provide a full Aston Martin Lagonda Ltd Lifetime Warranty at a cost of £1595.00. This is obviously a good indication that the car was in top condition at the time in that these Factory Warranty's are only provided if the cars are checked thoroughly as to whether they are good enough and whether they have been serviced correctly. The above work remember was all undertaken by Chapman Spooner Ltd who were officially appointed Aston Martin service agents at the time. It would seem that the new owner also arranged for Chapman Spooner Ltd to provide a private registration number at a price of £1885.87 against their invoice number 10458.)

(Clean down engine bay and check clutch operation, remove gear box, replace faulty clutch assembly, fit new clutch slave cylinder, bleed clutch, remove cross shaft in bell housing, clean and lubricate, reassemble and refit gear box, repair fault in headlamp, replace air conditioning control unit and wiring after investigation, check fault on alarm system, check exhaust height - invoice number 10514 -£1912.24)

09/04/98 - H.W.M. Ltd invoice 3884 - £47.00 for a carpet.

We are assured verbally by Lord G's son that the car sills and chassis in general were restored prior to the family selling the car.

14/09/00 - Car Care Works ltd invoice - £511.12 for black over mats and black boot carpets all bound in black hide.

19/09/00 - Car Care Works Ltd invoice number 3408 - £259.50 (unspecified work)

(Vehicle inspection, fit new clutch master cylinder, fit 2 new exhaust flexis and lower manifolds, replace studs in upper manifolds as necessary, fit new exhaust mount rubbers and bushes, fit two new tyres)

At this point - 09/06/01 the car was sold by Runnymede Motor Company to Mr G of Hampshire for £47000.00. We have the original sales invoice. The service history stamped booklet shows a Runnymede service 13/06/01 at 65730 miles.

Support engine remove and strengthen engine mounts, set engine height. Remove front brake calipers, re-grease and adjust front wheel bearings, have discs reground, bleed brake system. wheel centre lock covers, fit new drive belts, new engine oil and oil filter, new spark plugs, new spark plug leads, new air filters. New near side head lamp assembly, fit new spacers to both front seats. Carry out the remainder of work in a 5000 mile service not covered in the above and road test).
